Dear Community,

As we come to the end of Week 3 of Term 3, I would like to say "THANK YOU" to all of you, the members of our St. Paul's 'family', for all your efforts & support, as we come to terms with & respond to the surge in COVID-19 cases throughout Greater Melbourne and particularly in the Brimbank Local Government Area!

I would like to say a huge "THANK YOU" to our St. Paul's staff team for their time & effort in taking on Remote Learning 2.0, developing Continuity of Learning Plans: Version 4 and delivering the learning in varied formats including hard copy format (workbooks & worksheets), in online format (Google Sites) & in live format (Google Meets).

Together we continue to meet the unprecedented changes in our lives - at home, at school & at work - and we will come through this together.

Your children continue to develop their independence, resilience & ability to cope with change and we should all be very proud of them.

As parents, guardians & teachers, our role as the educators in the children's lives has never been more challenging yet vital; they continue to look to us for guidance, support & motivation in learning in new & different ways. And we need to continue to do our best to be there for them - guiding, supporting & motivating them on their learning journey.

To you our parents, guardians & grandparents, I again thank you for meeting the challenge of becoming teachers at home; you are doing an amazing job and it is wonderful for your children to see you as the educators you are in their lives.

To my staff team I again express my immense gratitude for going 'over & above' in their work, to ensure the children have remained connected to and interested in their learning. None of them could have ever had any understanding of or preparation for what remote learning would mean for them as members of our school staff team.

Our homes, local communities, wider communities, national community and global community continue to be hugely impacted by COVID-19 – we are 'not out of the woods' yet! With 723 cases notified across our state today and the tragedy of 19 deaths, this virus is deadly and it is everywhere; we have almost 700 active cases in our local government area of Brimbank alone. Schools very close to us are closing, with positive cases reported amongst their students, staff & families – meaning that schools are not safe places to be for our children and for our staff members right now. Once again I ask you to reconsider the need to be sending your children to school. In asking you to reconsider I am doing so out of genuine concern for the health & safety of your children, your families and our staff team; that being said, I also want to reassure you that we are here for your children if you need to send them to school.

What is happening in our Victorian community right now is a cause of ever increasing stress for all of us. I continue to remain hopeful that people will use their common sense and be considerate of others in how they go about their daily lives. It is becoming more & more evident that this virus does not limit itself to who it infects and we will be living with it for a long time to come. Let's all live safely & sensibly!

Please stay safe, look after yourself & your loved ones and listen to the advice that our local health experts are giving us.

SICK CHILDREN & COVID-19 TESTING

Dear Parents, Guardians and Carers,

Re: Nationally Consistent Collection of Data on School Students with Disability (NCCD)

Every year, all schools in Australia participate in the Nationally Consistent Collection of Data on School Students with Disability (NCCD). The NCCD process requires schools to identify information already available in the school about supports provided to students with disability. These relate to legislative requirements under the *Disability Discrimination Act 1992* and the Disability Standards for Education 2005, in line with the *NCCD guidelines* (2019).

Information provided about students to the Australian Government for the NCCD includes:

- year of schooling
- category of disability: physical, cognitive, sensory or social/emotional
- level of adjustment provided: support provided within quality differentiated teaching practice, supplementary, substantial or extensive.

This information assists schools to:

- formally recognise the supports and adjustments provided to students with disability in schools
- consider how they can strengthen the support of students with disability in schools
- develop shared practices so that they can review their learning programs in order to improve educational outcomes for students with disability.

The NCCD provides state and federal governments with the information they need to plan more broadly for the support of students with disability.

The NCCD will have no direct impact on your child and your child will not be involved in any testing process. The school will provide data to the Australian Government in such a way that no individual student will be able to be identified – the privacy and confidentiality of all students is ensured. All information is protected by privacy laws that regulate the collection, storage and disclosure of personal information. FINANCIAL ASSISTANCE INFORMATION FOR PARENTS

Every Victorian child should have access to the world of learning opportunities that exist beyond the classroom. The Camps, Sports and Excursions Fund helps ensure that no student will miss out on the opportunity to join their classmates for important, educational and fun activities. It is part of making Victoria the Education State and the Government's commitment to breaking the link between a student's background and their outcomes.

CAMPS, SPORTS & EXCURSIONS FUND (CSEF)

School camps provide children with inspiring experiences in the great outdoors, excursions encourage a deeper understanding of how the world works and sports teach teamwork, discipline and leadership. All are part of a healthy curriculum.

CSEF is provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. A special consideration category also exists for asylum seeker and refugee families. The allowance is paid to the school to use towards expenses relating to camps, excursions or sporting activities for the benefit of your child.

The annual CSEF amount per student is:

- \$125 for primary school students
- \$225 for secondary school students

HOW TO APPLY

New applicants should contact the school office to obtain a CSEF application form or download from www.education.vic.gov.au/csef

If you applied for the CSEF at your child's school in 2019, you do not need to complete an application form in 2020 unless there has been a change in your family circumstances.

You only need to complete an application form if any of the following changes have occurred:

- new student enrolments; your child has started or changed schools in 2020 or you did not apply in 2019.
- changed family circumstances; such as a change of custody, change of name, concession card number, or new siblings commencing at the school in 2020.

Check with the school office if you are unsure.

سيتم توفير CSEF من قبل حكومة فيكتوريا لمساعدة الأسر المؤهلة لتخطية تكاليف الرحانت والمخيمات والأنشطة الرياضية المدرسية.

إذا كنتم تملكون بطاقة التخفيضات الخاضعة الخاضعة لإختيار المدخول سارية المفعول أن كنتم والدي التيني المؤقف، فقد تكونوا مؤاهين للحصول على CSEF. توجد أيضا فئة الإعتبارات الخاصة لطالبي اللجوء والأسر المنجئة. يتم دفع المخصصات إلى المدرسة لإستخدامها في ما يتعلق بالنقات المتعلقة بالمخيمات والرحانت والأشطة الرياضية لصباح طفلكم.

إن مبلغ CSEF السنوي لكل طالب هي:

- 125 دولار لطائب العدارس الإبتدائية
- 225 دولار لطائب المدارس الثانوية

QUÝ DÀNH CHO CẨM TRẠI, THỂ THAO & DU NGOẠN (CSEF)

Đi cầm trại với trường sẽ cho các em những trải nghiệm lý thú ở bên ngoài, các cuộc du ngoạn khuyến khích tìm hiểu sâu sắc hơn về hoạt động của thế giới còn thể thao dạy các em kỹ năng làm việc theo nhóm, kỳ luật và lành đạo. Tất cả đều nằm trong khuôn khổ một chương trình giảng dạy lành mạnh.

CSEF sẽ được Chính phủ tiểu bang Victoria cung cấp nhằm trợ giúp các gia đình hội đủ điều kiện để trang trải chi phí cho các hoạt động du ngoạn, cấm trại và thể thao ở trường.

Nếu quý vị có thẻ giảm giá hợp lệ được cấp dựa trên trắc nghiệm tài chánh hoặc là cha mẹ nuôi tạm thời (foster parent), quý vị có thể hội đứ điều kiện để được nhận CSEF. Ngoài ra còn có một tiêu chuẩn cân nhậc đặc biệt dành cho các gia đình tấm trú và tị nạn. Khoán phụ cấp nhy được trả cho trường để sử dụng cho các chi phí liên quan tới các hoạt động cấm trại, du ngoạn hoặc thể thao phục vụ lợi ích con em quý vị.

Số tiến CSEF hàng năm cho mỗi học sinh là:

- \$125 cho học sinh tiểu học
- \$225 cho học sinh trung học
